Explanation:

If 60-year-old Patty has contributed \$36,000 to the annuity that is now worth \$69,000 and decides to withdraw \$15,000 as a lump sum, the \$15,000 will be taxed as ordinary income. She will not be subject to any penalties for early withdrawals since she is over 59 1/2 years old, but the IRS uses LIFO-last-in/first-out-accounting in determining whether the income is taxable, so the \$15,000 withdrawal will be considered to come from earnings, which have grown tax-free and are, therefore, now taxable.
