```

```
ReadWrite | Update-AzureRmVM
```

The first command gets the virtual machine named ContosoVM07 by using Get-AzureRmVM. The command stores it in the \$VM variable. The second command modifies the caching mode for the data disk named DataDisk01 on the virtual machine in \$VM. The command passes the result to the Update-AzureRmVM cmdlet, which implements your changes. A change to the caching mode causes the virtual machine to restart.
